

台灣青少年犯罪防治研究期刊

徵稿辦法

一、 期刊性質：

本期刊為學術性刊物，主要收受青少年犯罪，非行行為等相關研究議題為主，但不以此為限，尚包含霸凌、修復式司法、和平行為倡導等，由「台灣青少年犯罪防治研究學會」主編，每年定期於六月、十二月各出版一期。歡迎國內外相關學術理論與實徵性研究報告之發表。但已在他處發表之文稿恕不刊登。

二、 稿件格式：

（一） 來稿請依「台灣青少年犯罪防治期刊」論文格式撰寫文稿，並請用電腦橫打，註明頁碼。

（二） 一律以電子郵件 word 檔案投稿，中英文摘要，均各 500 字，並文末附上二千字內的英文長摘要。

（三） 中文全文文長以兩萬字為度，至多請勿超過三萬字；英文稿件英文以一萬字為上限，至多請勿超過一萬五千字（均包含中英文摘要、注釋、參考書目、附錄、圖表等）。

（四） 來稿須附中、英文摘要，並附中英文篇名、作者姓名、職稱、關鍵字。

（五） 全文中文請用標楷體、英文請用 Times New Roman 撰寫，內文則使用固定行高 22pt。

（六） 來稿若為碩、博士論文改寫，一經決定刊登，須註明「本文為碩、博士論文改寫，指導教授為□□□教授」。

（七） 若為共同撰稿之論文，請依貢獻比率排定共同作者順序，並請填具共同撰寫者貢獻。

三、 審查修正：

（一） 來稿刊出前須經正式之審查程序，論文由相關領域之編輯委員委託兩名相關學者專家審稿，若二名審查委員之意見不一，則另尋第三位審查委員再做審查，總合三位審查委員意見決定是否刊登。

（二） 凡經審查委員建議修改之處，將寄回稿件請作者依建議事項修改後，再

行刊登。

(三) 本刊因編輯需要，保有刪修權。

四、 著作財產權事宜：

來稿如有一稿多投，或侵犯他人著作權、違反學術倫理者，除由作者自負相關的法律責任外，兩年內本刊不再接受該位作者投稿。所謂一稿多投，包括題目不同，但內容大同小異，且已在其他刊物發表，或同時投稿本刊及其他刊物者。投稿時，請作者於「投稿者基本資料表」內簽寫切結書。

五、 截稿事項

(一) 本刊全年收稿，隨到隨審。

六、 來稿一經採用，即致贈當期刊物二冊，以及其著作 PDF 檔，不另支稿費；退稿將致函作者，但不退還文稿，請於投稿前自行留存原稿。

七、 本辦法經本刊編輯委員會會議通過後實施，修正時亦同。

Call for Papers

I. Characteristic of the Journal

This journal is an academic journal that focuses on research issues related to juvenile delinquency and delinquent behavior, but not limited to bullying, restorative justice, and peaceful action. It is edited by the Taiwan Society of Delinquency Research and Prevention and is published regularly every year, one issue in June and one issue in December. Domestic and foreign academic theories and empirical research reports are welcome. However, manuscripts already published elsewhere will not be published.

II. Manuscript Format

1. The manuscript should be written in the format of “Journal of Research in Delinquency and Prevention” and typed horizontally on a computer with page numbers.
2. All manuscripts should be submitted by e-mail in a word file, with a 500-word abstract in both English and Chinese, and a 2,000-word long abstract in English at the end of the paper.
3. The length of the full text in Chinese should be 20,000 words, not exceeding 30,000 words; the length of the full text in English should be 10,000 words, not exceeding 15,000 words (including English and Chinese abstracts, explanations, bibliographies, appendices, and charts).
4. Abstracts in both English and Chinese should be attached to the manuscript, along with the title of the article, author's name, title, and keywords in English and Chinese.
5. The entire text should be written in italics in Chinese and Times New Roman in English, with a fixed line height of 22pt.
6. If the manuscript is a rewrite of a master's or doctoral thesis, once the decision is made to publish the manuscript, it must be marked “This is a rewrite of a master's or doctoral thesis, and the supervising professor is Prof. □□□□”.
7. If the paper is co-authored, please rank the co-authors according to the contribution ratio and fill in the contribution of the co-authors.

III. Review and Correction

1. A formal review process is required before publication. Two scholars and experts in the relevant fields are commissioned by the editorial board in the relevant fields to review the paper; if two reviewers have different opinions, a third reviewer will be sought to review the paper again, and a total of three reviewers will decide whether or not to publish the paper.
2. Where the reviewers suggest changes, the manuscript will be sent back to the authors for modification according to the suggestions before publication.
3. The journal reserves the right to delete or revise the manuscript for editorial purposes.

IV. Copyright matters

In the event of multiple submissions, infringement of others' copyrights, or violation of academic ethics, the journal will not accept any further submissions from the author for two years, in addition to the author's own legal responsibility. Multiple submissions include articles with different titles but similar content that have been published in other journals or submitted to the Journal and other journals at the same time. When submitting a manuscript, authors are requested to sign the "Author's Personal Information Form" with an acknowledgement.

V. Deadline

The journal accepts manuscripts throughout the year and reviews them on a first-come, first-served basis.

VI. Upon acceptance of a manuscript, the author will receive two copies of the current issue of the journal and a PDF file of his/her book without additional payment. A letter of rejection will be sent to the author, but the manuscript will not be returned.

VII. This policy will be implemented after it has been approved by the Editorial Board of the journal, and will be amended in the same way.
